

## VALLARTA AT THE BOWL

### OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. SOME RESTRICTIONS APPLY. THE SWEEPSTAKES IS SUBJECT TO ALL FEDERAL, STATE AND LOCAL LAWS, RULES AND REGULATIONS.**

- 1. Eligibility:** The VALLARTA AT THE BOWL – TCHAIKOVSKY SPECTACULAR WITH FIREWORKS Sweepstakes (“**Sweepstakes**”) is open only to residents of the State of California, United States of America, who are at least 18 years old at the time of entry. Each participant is limited to a maximum of one (1) entry in the Sweepstakes by any method. Any attempt by any participant to obtain more than one entry into the Sweepstakes will void that participant’s entries and that participant may be disqualified from the Sweepstakes and any of Sponsor’s other promotions. The use of any agency, program, bot, application, device or any automated system to enter is strictly prohibited, and will result in disqualification. Proof of sending

or submission will not be deemed to be proof of receipt by the Sponsor and/or Administrator. Entries are the sole and exclusive property of Vallarta Supermarkets upon transmission. Entries will not be acknowledged or returned.

7. **Drawings:** The winner will be chosen by random drawing from all valid and eligible entries received.
8. **Prizes:** ONE FAMILY FOUR PACK – FOUR (4) TICKETS TO THE HOLLYWOOD BOWL TCHAIKOVSKY SPECTACULAR WITH FIREWORKS PLUS ONE (1) \$100 VALLARTA SUPERMARKETS GIFTCARD. There will be ONE (1) winner total. Only one prize per Household. Prizes are not transferable, and no assignment or substitution of a prize, and no cash substitution, is permitted, except Vallarta Supermarkets reserves the right to substitute a prize of equal or greater value if the awarded prize is unavailable for any reason. Winner is solely responsible for paying all federal, state and local taxes (including any sales taxes). Any person winning over \$600 in prizes during any one year period will receive an IRS Form 1099 at the end of the calendar year, and a copy of such form will be filed with the IRS.

If Winner cannot be contacted, or does not respond, within five (5) business days after the first attempt to contact him/her or if he/she fails to return the signed Affidavit of Eligibility and liability/publicity releases within the required time, the Prize will be deemed forfeited and an alternate Winner will be selected in his/her place in a random drawing from among the remaining eligible entries received. If any alternate Winner similarly fails to respond or declines the Prize, Sponsor will use a reasonable number of attempts, in its discretion, to award the Prize to another alternate Winner, but if it is unable to do so, the Prize will be finally forfeited and Sponsor shall have no further liability in connection with this Sweepstakes. Return of any Prize notification or Prize as undeliverable will result in disqualification and an alternate Winner will be selected, if time reasonably permits. In such event, Vallarta Supermarkets may award the Grand Prize at random from among the eligible entries received up to the time of the impairment. Vallarta Supermarkets may, in its sole discretion, disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules, or in any unsportsmanlike, disruptive or fraudulent manner. Vallarta Supermarkets' failure to enforce any term of these official Rules shall not constitute a waiver of that provision.
